## Introduction

The Valuation Office Survey of 1910 resulted in the creation of a snapshot of land across the county of Worcestershire, in common with other counties in England. The associated Valuation Summary books are to be found at the Hive in Worcester: these books are of a large format, measuring 43cm by 34cm, cloth-bound with leather corners and the name of the Income Tax Parish (ITP) written on the spine. An ITP may cover just a single civil parish in the county, whilst some ITPs covered two or more parishes: for example, the ITP of Church Lench only contains records for the civil parish of Church Lench, whilst that of Abbots Lench covers the civil parishes of Fladbury, Hill & Moor, Throckmorton and Wyre Piddle, as well as Abbots Lench itself. In some cases, two or more ITPs can be found in the same Valuation Summary book: for example, Conderton and Overbury. The basic unit of valuation was a piece of land in separate occupation, although the application of this principle was not always straightforward.<sup>1</sup> The number of valuation assessments in each ITP ranges across the county from 7 (Kenswick) to 7,171 (Kidderminster Borough).

This series of booklets provides a transcription of the Valuation Summary books for each civil parish in the county of Worcestershire, along with a brief analysis of the transcribed data.

## 1. The Valuation Office Survey of 1910

The valuation of land in 1910 was initiated by the Finance (1909-1910) Act (10 Edw. VII, c.8 section 26(1)) which provided for the levy and collection of a duty on the increment value of all land in the United Kingdom. The main object of the Act was to tax that part of the capital appreciation of real property which was attributable to the site itself, excluding any benefit arising from crops, buildings or improvements paid for by the owners. In this way, private owners were required to pay part of the increase in the site value of their land which had resulted from the expenditure of public money on communal developments such as roads or public services.

Increment value duty was based on the difference between the amount of two valuations. The first was the site value as at 30 April 1909, as determined by the Valuation Survey, which constituted the 'datum line' for these purposes: a second site valuation was to be taken on the occasion of any subsequent sale or grant of a lease, transfer of interest in a piece of land, or the subsequent death of a land owner, in order to determine any potential payment of increment value duty. This second assessment formed part of the on-going role of the Valuation Office, until this duty was repealed by the 1920 Finance Act (10 and 11 Geo. V, c.18). Although this legislation was only in place for around ten years, it has left behind a comprehensive record of land in every county enabling an understanding of the ownership, occupation, extent and value of land. The data collected during the survey for the county of Worcestershire, which has been retained, is contained in four different sets:

- The Valuation Summary books (sometimes referred to as the Lloyd George Domesday books): these are held at the Hive in Worcester (WAAS: BA8585/1 series);
- Forms 37 – Land: these contain the provisional valuations, and are also held at the Hive in Worcester (WAAS: 8585/2-64 series);
- Two series of annotated Ordnance Survey maps: the Field Maps (used in the field during survey), some of which are now held at the Hive in Worcester; the Record Maps (originally

kept in the Valuation Record office) now held at the National Archives at Kew (TNA: IR129 series);

- The Field Books which contain a complete record of each valuation: again, these are held at the National Archives at Kew (TNA: IR58 series).

With regard to the Valuation Summary books, the first nine columns were compiled from the Rate Book for the parish and all of the books contain this information. Subsequent columns (10-40) were supposed to be completed by the staff of the District Valuation Offices after the initial valuation was complete: however, this was not carried out in a consistent fashion, and indeed, anyone interested in the mechanics and outcome of an individual valuation would be better served by the details contained in the Field Books.

This series of booklets provides a transcription of the first nine columns in that these record the ownership, occupation, extent, and basic valuation of each assessment. After a brief introduction to the parish, an analysis of the data will be presented examining the names of the major landowners and the extent of their property in the parish, along with an analysis of the main farms in the parish. Indexes of owners, occupiers and places appear in subsequent appendices and a final appendix will direct the reader to the appropriate references for the associated Forms 37, Record Maps and Field Books for the parish covered by the booklet.

The Valuation Summary for the Income Tax Parish of Aldington is contained in the summary book covering the civil parishes of Aldington, Badsey, Bretforton and Wickhamford. This booklet covers the civil parish of Badsey only.<sup>2</sup>

## 2. The parish of Badsey in 1910

The parish is located 2¼ miles east from Evesham on a geology described as ‘Blue Lias Formation & Charmouth Mudstone Formation - Mudstone’, extending to 1,208 acres. The resulting soils are primarily clay to clayey loam, and clayey loam to sandy loam, with clay to sandy loam adjacent to Badsey Brook.<sup>3</sup>

When the census was carried out in 1911, the population of Badsey was 1,127 (580 males and 547 females): of the 257 properties recorded in the census, 245 were inhabited, eight were uninhabited, and four were classed as a ‘building not used as dwelling’.<sup>4</sup> From an agricultural viewpoint in the same year, the available statistics for Badsey appear to include the parish of Aldington: the combined cultivated acreage was 1,645¼ acres, which can be compared to the acreages given in Kelly’s 1912 directory of 1,208 for Badsey and 669 for Aldington, making a total of 1,877 acres.<sup>5</sup> The total acreage under cultivation was split between 1226¼ acres of arable and 419 acres of grassland (25%). 288 holdings were recorded in 1911, with only three owned, the rest being tenanted holdings. Whilst the main arable crops were beans, peas and wheat, the largest individually recorded acreage was 463 acres of ‘Other crops’: there was no separate recording of market gardening produce at this time, and these crops would have been classed under that category. In addition, there were 206 acres of small

fruit and 243 acres of orchards.<sup>6</sup> With just one-quarter of the acreage recorded as grassland, there were only 45 cattle and 199 sheep kept in the parish.

### 3. Land and property in 1910 in the parish of Badsey

In preparing the data for analysis, a series of standardisations have been made: see Appendix 6 for full details.

Of the 505 assessments with owners recorded in the Valuation Summary, the top six landowners in terms of the number of assessments, were also the top six in terms of acreage, but not necessarily in the same order: see Table 1 and Table 2.

## Appendix 6. Data standardisations made for the parish of Badsey.

In preparing the data for analysis, the following standardisations have been made:

- Where entries appear in either owner names or occupier names, which use abbreviations or the full name, the listings in Appendices 2 and 3 show the full name for all variations: for example, for cases with the same surname only, where *Wm.*, *Willm.*, and *William* appear, these are all recorded under *William*; where only *Wm.* and *Willm.* appear, these will be recorded under *Wm.*; but those entries with only the initial *W.* are not assumed to be *William*.
- Using the above logic, then:
  - *Albt.* and *Albert* are recorded as *Albert*
  - *Alfd.* and *Alfred* are recorded as *Alfred*;
  - *Chas.* and *Charles* are recorded as *Charles*;
  - *Fredk.* and *Frederick* are recorded as *Frederick*;
  - *Geo.* and *George* are recorded as *George*;
  - *Hy.* and *Henry* are recorded as *Henry*;
  - *Jas.* and *James* are recorded as *James*;
  - *Jno.* and *John* are recorded as *John*;
  - *Thos.* and *Thomas* are recorded as *Thomas*.
- Two variations of owner names, *John Dilnot Sladden & others* and *John Dilnot Sladden & others* are shown in Appendix 1. The listings in Appendix 2 show *Sladden, John Dilnot & others* for both variations;<sup>84</sup>
- Three variations of owner names, *Trustees of Cap Lord*, *Trustees of late Cap Lord* and *Lords Trustees* are shown in Appendix 1: the listing in Appendix 2 shows *Lord, Capt., Late, Trustees of* for all variations.<sup>85</sup>
