#### Introduction

The Valuation Office Survey of 1910 resulted in the creation of a snapshot of land across the county of Worcestershire, in common with other counties in England. The associated Valuation Summary books are to be found at the Hive in Worcester: these books are of a large format, measuring 43cm by 34cm, cloth-bound with leather corners and the name of the Income Tax Parish (ITP) written on the spine. An ITP may cover just a single civil parish in the county, whilst some ITPs covered two or more parishes: for example, the ITP of Church Lench only contains records for the civil parish of Church Lench, whilst that of Abbots Lench covers the civil parishes of Fladbury, Hill & Moor, Throckmorton and Wyre Piddle, as well as Abbots Lench itself. In some cases, two or more ITPs can be found in the same Valuation Summary book: for example, Conderton and Overbury. The basic unit of valuation was a piece of land in separate occupation, although the application of this principle was not always straightforward. The number of valuation assessments in each civil parish ranges across the county from 1 (Crutch) to 7,171 (Kidderminster Borough).

This series of booklets provides a transcription of the Valuation Summary books for each civil parish in the county of Worcestershire, along with a brief analysis of the transcribed data.

# 1. The Valuation Office Survey of 1910

The valuation of land in 1910 was initiated by the Finance (1909-1910) Act (10 Edw. VII, c.8 section 26(1)) which provided for the levy and collection of a duty on the increment value of all land in the United Kingdom. The main object of the Act was to tax that part of the capital appreciation of real property which was attributable to the site itself, excluding any benefit arising from crops, buildings or improvements paid for by the owners. In this way, private owners were required to pay part of the increase in the site value of their land which had resulted from the expenditure of public money on communal developments such as roads or public services.

Increment value duty was based on the difference between the amount of two valuations. The first was the site value as at 30 April 1909, as determined by the Valuation Survey, which constituted the 'datum line' for these purposes: a second site valuation was to be taken on the occasion of any subsequent sale or grant of a lease, transfer of interest in a piece of land, or the subsequent death of a land owner, in order to determine any potential payment of increment value duty. This second assessment formed part of the on-going role of the Valuation Office, until this duty was repealed by the 1920 Finance Act (10 and 11 Geo. V, c.18). Although this legislation was only in place for around ten years, it has left behind a comprehensive record of land in every county enabling an understanding of the ownership, occupation, extent and value of land. The data collected during the survey for the county of Worcestershire, which has been retained, is contained in four different sets:

- The Valuation Summary books (sometimes referred to as the Lloyd George Domesday books): these are held at the Hive in Worcester (WAAS: BA8585/1 series);
- Forms 37 Land: these contain the provisional valuations, and are also held at the Hive in Worcester (WAAS: 8585/2-64 series);
- Two series of annotated Ordnance Survey maps: the Field Maps (used in the field during survey), some of which are now held at the Hive in Worcester; the Record Maps (originally

kept in the Valuation Record office) now held at the National Archives at Kew (TNA: IR129 series);

• The Field Books which contain a complete record of each valuation: again, these are held at the National Archives at Kew (TNA: IR58 series).

With regard to the Valuation Summary books, the first nine columns were compiled from the Rate Book for the parish and all of the books contain this information. Subsequent columns (10-40) were supposed to be completed by the staff of the District Valuation Offices after the initial valuation was complete: however, this was not carried out in a consistent fashion, and indeed, anyone interested in the mechanics and outcome of an individual valuation would be better served by the details contained in the Field Books.

This series of booklets provides a transcription of the first nine columns in that these record the ownership, occupation, extent, and basic valuation of each assessment. After a brief introduction to the parish, an analysis of the data will be presented examining the names of the major landowners and the extent of their property in the parish, along with an analysis of the main farms in the parish. Indexes of owners, occupiers and places appear in subsequent appendices and a final appendix will direct the reader to the appropriate references for the associated Forms 37, Record Maps and Field Books for the parish covered by the booklet.

This booklet presents the data for the civil parish of Ripple: it has been taken from the summary book for the Income Tax Parish of Croome d'Abitot which covers the civil parishes of Croome d'Abitot, Earls Croome, Hill Croome, Ripple and Severn Stoke.<sup>2</sup>

# 2. The parish of Ripple in 1910

The parish is located 4 miles north from Tewkesbury and 3 miles south from Upton, on a mixture of geology described as 'Sidmouth Mudstone', 'Arden Sandstone' and 'Branscombe Mudstone' formations, extending to 2,412 acres. The resulting soils are primarily freely-draining slightly-acid loamy soils, and loamy and clayey floodplain soils with naturally high groundwater.<sup>3</sup> When the census was carried out in 1911, the population of Ripple was 705 (332 males and 373 females): of the 204 properties recorded in the census, 191 were inhabited, 10 were uninhabited, and three were classed as a 'building not used as dwelling'.<sup>4</sup>

From an agricultural viewpoint in the same year, the total cultivated area of the parish was 3,371 acres, of which 1,026½ were arable, and 2,344¾ acres (70% of the total) were grassland: there was also 143½ acres of orchards, 109 acres of which were counted under permanent grassland. Of the 48 agricultural holdings in the parish, 44 were tenanted properties covering 3,151½ acres (93% of the total). The main arable crops were wheat, beans, oats, peas, turnips and swedes, and barley. Orchards were growing mainly apples. With more pasture land than arable, 686 cattle and 1,456 sheep were kept.

# 3. Land and property in 1910 in the parish of Ripple

In preparing the data for analysis, a series of standardisations have been made: see Appendix 6 for full details.

Of the 357 assessments with owners recorded in the Valuation Summary, those with the greatest numbers of assessments were the Ecclesiastical Commissioners, Rev. H. C. Phelps, and the Midland Railway Company: see Table 1. Therefore, the Ecclesiastical Commissioners and Rev. H. C. Phelps were the major landowners in terms of both numbers of assessments and acreage owned (see Table 2).

#### NOTE:

- 1. This data has been transcribed as presented in the Valuation Summary without any standardisation of punctuation, abbreviation &c. However, all data presented as superscripts has been included as normal text in this transcription.
- 2. There is no Assessment Number 273.
- 3. After Assessment Number 329, the numbers were not originally sequential: this was corrected as a later date to create a sequential series, and for these assessments, both the original numbers (greyed out as a representation of the deletion made in the original summary book) and revised numbers are presented below. However, the sequential numbering will be used in the indexes in Appendices 2, 3 and 4, to avoid any confusion with the assessments in the parish of Severn Stoke which commence with Assessment Number 562.

- Where entries appear in either owner names or occupier names, which use abbreviations or the full name, the listings in Appendices 2 and 3 show the full name for all variations: for example, for cases with the same surname only, where *Geo* and *George* appear, these are all recorded under *George*; however, those entries with only the initial *G*. are not assumed to be *George*;
- Using the above logic, then:
  - Elizth and Elizabeth are recorded as Elizabeth;
  - Saml and Samuel are recorded as Samuel;
  - o Thos and Thomas are recorded as Thomas;
  - Wm and William are recorded as William.
- Two variations of owner names, *Payne Marriot Percy* and *Payne Marriott Percy* are shown in Appendix 1: the listing in Appendix 2 shows *Payne, Percy Marriott* for both variations;<sup>47</sup>
- Three variations of occupier names, *County Council of Worcestershire*, *County Council* and *Worcestershire County Council* are shown in Appendix 1: the listing in Appendix 3 shows *Worcestershire County Council* for both variations;
- Five variations of owner and occupier names, *Eccl Commissioners, Eccles Commrs, Eccl Commrs, Ecclesiastical Commis.* and *Eccles Commissioners* are shown in Appendix 1: the listings in Appendices 2 and 3 show *Ecclesiastical Commissioners* for all variations;
- Two variations of owner and occupier names, *Earl Coventry* and *Earl of Coventry* are shown in Appendix 1: the listings in Appendices 2 and 3 shows *Coventry*, *Earl of* for both variations.
