Introduction

The Valuation Office Survey of 1910 resulted in the creation of a snapshot of land across the county of Worcestershire, in common with other counties in England. The associated Valuation Summary books are to be found at the Hive in Worcester: these books are of a large format, measuring 43cm by 34cm, cloth-bound with leather corners and the name of the Income Tax Parish (ITP) written on the spine. An ITP may cover just a single civil parish in the county, whilst some ITPs covered two or more parishes: for example, the ITP of Church Lench only contains records for the civil parish of Church Lench, whilst that of Abbots Lench covers the civil parishes of Fladbury, Hill & Moor, Throckmorton and Wyre Piddle, as well as Abbots Lench itself. In some cases, two or more ITPs can be found in the same Valuation Summary book: for example, Conderton and Overbury. The basic unit of valuation was a piece of land in separate occupation, although the application of this principle was not always straightforward.¹ The number of valuation assessments in each civil parish ranges across the county from 1 (Crutch) to 7,171 (Kidderminster Borough).

This series of booklets provides a transcription of the Valuation Summary books for each civil parish in the county of Worcestershire, along with a brief analysis of the transcribed data.

1. The Valuation Office Survey of 1910

The valuation of land in 1910 was initiated by the Finance (1909-1910) Act (10 Edw. VII, c.8 section 26(1)) which provided for the levy and collection of a duty on the increment value of all land in the United Kingdom. The main object of the Act was to tax that part of the capital appreciation of real property which was attributable to the site itself, excluding any benefit arising from crops, buildings or improvements paid for by the owners. In this way, private owners were required to pay part of the increase in the site value of their land which had resulted from the expenditure of public money on communal developments such as roads or public services.

Increment value duty was based on the difference between the amount of two valuations. The first was the site value as at 30 April 1909, as determined by the Valuation Survey, which constituted the 'datum line' for these purposes: a second site valuation was to be taken on the occasion of any subsequent sale or grant of a lease, transfer of interest in a piece of land, or the subsequent death of a land owner, in order to determine any potential payment of increment value duty. This second assessment formed part of the on-going role of the Valuation Office, until this duty was repealed by the 1920 Finance Act (10 and 11 Geo. V, c.18). Although this legislation was only in place for around ten years, it has left behind a comprehensive record of land in every county enabling an understanding of the ownership, occupation, extent and value of land. The data collected during the survey for the county of Worcestershire, which has been retained, is contained in four different sets:

- The Valuation Summary books (sometimes referred to as the Lloyd George Domesday books): these are held at the Hive in Worcester (WAAS: BA8585/1 series);
- Forms 37 – Land: these contain the provisional valuations, and are also held at the Hive in Worcester (WAAS: 8585/2-64 series);

- Two series of annotated Ordnance Survey maps: the Field Maps (used in the field during survey), some of which are now held at the Hive in Worcester; the Record Maps (originally kept in the Valuation Record office) now held at the National Archives at Kew (TNA: IR129 series);
- The Field Books which contain a complete record of each valuation: again, these are held at the National Archives at Kew (TNA: IR58 series).

With regard to the Valuation Summary books, the first nine columns were compiled from the Rate Book for the parish and all of the books contain this information. Subsequent columns (10-40) were supposed to be completed by the staff of the District Valuation Offices after the initial valuation was complete: however, this was not carried out in a consistent fashion, and indeed, anyone interested in the mechanics and outcome of an individual valuation would be better served by the details contained in the Field Books.

This series of booklets provides a transcription of the first nine columns in that these record the ownership, occupation, extent, and basic valuation of each assessment. After a brief introduction to the parish, an analysis of the data will be presented examining the names of the major landowners and the extent of their property in the parish, along with an analysis of the main farms in the parish. Indexes of owners, occupiers and places appear in subsequent appendices and a final appendix will direct the reader to the appropriate references for the associated Forms 37, Record Maps and Field Books for the parish covered by the booklet.

This booklet presents the data for the civil parish of Feckenham Urban: it has been taken from one of the two summary books for the Income Tax Parish of Feckenham, which covers the civil parishes of Feckenham Urban and Feckenham.² Assessment Numbers 1560 to 1699 are preceded by the heading ‘Particulars not in Rate Book’ and an inspection of these assessments shows that some are in Feckenham Urban parish, whilst others are in Feckenham parish. Although it is possible to allocate some of the assessments to one or other of the two parishes, it is not possible to do this securely for all of these assessments. Therefore, the assessments numbered 1560 to 1699 are listed in a separate table in Appendix 1, as well as in the corresponding booklet for the parish of Feckenham.³ These assessments are included in the indexes in Appendices 2, 3 and 4, but are excluded from the analysis in Section 3.

2. The parish of Feckenham Urban in 1910

The parish of Feckenham Urban was formed under the provisions of the Local Government Act 1894 from Feckenham and includes parts of Headless Cross: the area is 127 acres. Located 13 miles north-east of Worcester and 5 miles south-west of Redditch, the parish lies on a geology described primarily as ‘Branscombe Mudstone Formation’. The resulting soils are a mixture of slightly-acid loamy and clayey soils with impeded drainage, slowly-permeable seasonally-wet slightly-acid but base-rich loamy and clayey soils, and loamy and clayey floodplain soils with naturally high groundwater.⁴

When the census was carried out in 1911, the population of Feckenham Urban was 845 (411 males and 434 females): of the 227 properties recorded in the census, 212 were inhabited, six were uninhabited, three were classified as ‘building’, and six were classed as a ‘building not used as

dwelling'.⁵ From an agricultural viewpoint in the same year, there are no separate statistics for the parish of Feckenham Urban, and in all likelihood, they were included in those for the parish of Feckenham. The total cultivated area of the parish was 5,602 acres (within the total area of Feckenham and Feckenham Urban, that being 6,960 acres), of which 14% was arable: the main arable crops were wheat, beans, and oats.⁶

3. Land and property in 1910 in the parish of Feckenham Urban

As noted in Section 1, this analysis excludes Assessment Numbers 1560 to 1699. In preparing the data for analysis, a series of standardisations have been made: see Appendix 6 for full details.

Of the 259 assessments with owners recorded in the Valuation Summary, there was no overall major landowner. Table 1 shows the number of assessments held by each landowner where they held 10 or more assessments each: being an urban parish, many of the assessments had no associated land.

There are no assessments with more than 25 acres of land in the parish: the largest individual area of land is at Headless Cross (Assessment number 1300), and extends to 20 acres, 0 roods and 34 perches.

Appendix 1. Transcribed data from the Valuation Summary for the parish of Feckenham Urban

NOTE:

1. This data has been transcribed as presented in the Valuation Summary without any standardisation of punctuation, abbreviation &c. However, all data presented as superscripts has been included as normal text in this transcription.
2. Many of the assessment numbers were not given as complete numbers in the Valuation Summary: for example, between 1500 and 1510, the numbers are written as 1500, 1, 2, 3, ... 9, 1510. In order to provide an accurate cross-reference between the data in this appendix, and that in Appendices 2, 3 and 4, the assessment numbers have been completed in full in the table below.
3. The Valuation Summary for the parish of Feckenham Urban was originally numbered with Assessment Numbers starting at 1: it was then combined with the civil parish of Feckenham to create the Income Tax Parish of Feckenham, and the assessments for Feckenham Urban were re-numbered, starting at 1300. Some of the references given in the footnotes to this appendix refer to the original numbering: notes have been added to indicate the appropriate revised number.
